# **Overview**

The purpose of this course is to provide an introduction to the policies and procedures, knowledge, and skill areas necessary for on-campus clinic placements. The course is designed to prepare students for graduate-level clinical practicum.


#### Approved Course Description (from CSUS Course Catalog)

#### WHY IS THIS COURSE IMPORTANT?

This course is important because it is the students' orientation to procedures used in audiology clinics. The concepts and activities presented in this class are the foundations of clinical knowledge and skills that are required for audiologists in a variety of settings.

#### **COURSE/CLASS POLICIES**

## **Course Format**

#### **Class Preparation:**

All required readings are for the date listed in the course schedule, not the following class period. Students are responsible for all assigned readings, whether discussed in class or not.

# Class Participation:

Students are expected to actively participate in class discussions and are required to have read the assigned material prior to class meetings.

## Class Attendance:

Classroom attendance is necessary for this course. No more than three unexcused absences are allowed. Students are expected to arrive on time as class begins at X:XX am/pm.

## **Class Assignments**

Knowledge and skills will be assessed through weekly quizzes, clinical observations and experiences, completion of required trainings, and a clinical practicum binder.

# **Required Trainings**

- HIPAA: Complete the Sacramento State HIPAA training modules by September 3, 2019.
  Print the certificate of completion and place in the clinical practicum binder.
- Tuberculosis: Submit a copy of the TB clearance to the clinic coordinator. Place a copy of the clearance form in the clinical practicum binder. Note: this screening needs to be completed annually.
- CPR: Place a copy of the front and back of the CPR card in the clinical practicum binder.
- Hepatitis B vaccination: Place a copy of all relevant vaccinations (MMR, Hepatitis B, etc.) in the clinical practicum binder.
- Certificate of clearance: Place a copy of the Certificate of Clearance in the clinical practicum binder.

# Quizzes

Quizzes will be available online for a week after completion of the in-class lecture. It is the student's responsibility to check the site for quiz due dates. There will be 10 quizzes throughout the semester. All quizzes are to be completed individually.

#### **Clinical Observation**

Students are expected to accrue at least 25 observation hours in audiology and five hours in speech-language pathology settings. These settings include on- and off-campus clinics, private practices, public schools, and hospitals. Audiology hours must be completed in at least three different settings. Students must obtain permission from the appropriate person to observe in any setting. It is the student's responsibility to record the number of hours, setting, and supervisor. All hours must be verified and signed by the supervisor on the form below. By October 1, at least 12 hours must be completed. Documentation of all 30 hours is due by December 3<sup>rd</sup>.

# **Clinical Observation Reflection**

Upon completion of 25 observation hours, students must write a one- to two-page reflection of the sessions. The focus of this reflection should be on the role of the audiologist as a health care profession, how the observation experience affected the knowledge gained in coursework, and any insight gained about oneself or the field. Reflection papers are due December 3<sup>rd</sup> in class.

# **Clinical Practicum Binder**

This binder allows students to compile information that will be useful in clinical settings. Information should be divided using tabs into the following sections:

- Required trainings and certifications
- Maryjane Rees Speech and Hearing Center policies
- CPT codes

## Class Activities

Class activities will provide opportunities to practice the concepts presented in CSAD: Audiologic evaluation.
