

The **Bachelor of Science in Public Health** is designed to give students a well-rounded core education in public health, while providing strong preparation in one of these two concentration areas:

Health Promotion addresses health issues and concerns related to the public and targeted populations. This includes assessing community needs, coordinating resources, and curating information on health issues for the public, to help people make informed decisions about health behaviors and improve health outcomes in their communities.

Occupational Safety & Health is concerned with the identification, prevention, and control of health and safety hazards in the workplace, applying principles drawn from health, management, law, psychology, physics, chemistry, and related fields that focus on preventing harm to people, property and the work environment.

They are responsible for facilities, service quality, personnel, budgets, marketing, and relations with other organizations. They work closely with governing boards and medical staff to develop plans, policies, and procedures, and monitor compliance.
