General Requirements

Dear Title IV-E Applicant,

The Title IV-E Stipend program was designed for students interested in working in a Public Child Welfare Agency. The Title IV-E Stipend Program has <u>mandatory requirements</u> that stipend recipients **MUST meet.**

We are <u>not accepting</u> the Part-time 3-year applications until 2024-2025 Academic year. Please contact us if you have questions.

Applicant MUST have a bachelor's degree from an accredited university/college (B.A., B.S., or B.S.W.) and will have the degree by August 2023.

Applicant MUST be accepted into MSW Program and have completed all academic prerequisites for the MSW graduate program by <u>January 20, 2023</u> and complete Statistics and Biology by August 2023.

Students MUST enroll in and successfully complete the Title IV-E designated selective courses.

Students **MUST** attain a minimum level of mastery in each of the identified competencies of child welfare practice.

If awarded the stipend, students **MUST** maintain their academic eligibility with a minimum 3.0 GPA each semester, students **MUST** receive a "B" or better in each course as well as complete the required fieldwork in to advance candidacy in a timely manner.

Note: If a full-time student becomes academically ineligible or decides to separate from the program, he/she will lose the stipend support and will be required to pay it back. If a student is in the Three-Year/Part-Time program and becomes academically ineligible or decides to separate from program, he/she will lose reimbursement support and will be required to pay it back as outlined in the contract signed during that academic year.

Students **MUST complete** the first year of fieldwork in a Public Child Welfare Agency or non-profit agency that serves Title IV-E populations (foster children). **Title IV-E and the Field Program** will place Title IV-E students in their first year of field placement. Students **MUST complete** the second year of fieldwork in a Public Child Welfare Agency, California Department of Social Services or an Indian Reservation/Rancheria.

Requirements Continued

Students are **required** to attend and participate in all Field Practicum training courses, during the academic year. These trainings are required in the first and second year of the program.

Students MUST maintain the legal residency requirements.

Students cannot be convicted of a felony or misdemeanors while in program, as noted on attachment to application.

Students participating in the Title IV-E stipend program **are not permitted** to pursue the Pupil Personnel Services Credential (PPSC).

Students MUST complete the full-time program within 2 years.

Students MUST complete the Advanced Placement program within 1 year.

Students MUST complete part time program within 3 years.

 - c) After completing the **Cal State application**, you will receive an e-mail from the Office of Graduate Studies with instructions for setting up your Sac Link account. Make sure to check your junk/spam folder for the email and check Office of Graduate studies website for any other requirements needed for the University.
 - d) You will have to submit this application and set up My Sac Link account before you can access the Division of Social Work MSW application.

- 8. DMV driving record. Go to DMV website and request a copy of your driving record and submit a copy.

Submit all the above documents to <u>rgonzal@csus.edu</u> via email or by Secure file. If you wish to send files by Secure file, make sure you request to above email for the secure file 10 days prior to the due date. All documents are due by <u>Friday</u>, <u>January 20</u>, <u>2023</u>.

Note: After we have received your three applications and above documents, applications go through a scoring process. Then after the scoring of the applications is complete, the selected applicants will be contacted by phone or by email and scheduled for an in-person interview in late February or in early March 2023. If the application does not make the selection process, then you will receive a waitlist or denial letter by email by the end of March 2023.
