

## 2023-2024 SCHOLARSHIPS

# 1. Applied Behavior Consultants Scholarship: \$250

Purpose: To support students with interests in behavior analysis.

Eligibility: Junior, Senior, **OR** graduate student standing. Psychology major. Half- or full-time status.

o Minimum overall GPA: 2.00

o Preference: Applied Behavioral Analysis

Required materials:

Application

One- to two-page paper describing professional or field experience, research, or papers presented and your interests in behavior analysis

## 2. June Gersten Memorial Scholarship: \$500 minimum

Purpose: To support a pre-doc MA student who is working towards admissions to a doctoral program in Clinical or Counseling Psychology.

Eligibility: A classified MA student in our Psychology pre-doc MA program. Half- or full-time status.

o Minimum overall GPA: 3.20

## 3. Duane E. C. Johnson Scholarship: \$500 minimum

Purpose: To support psychology majors of junior or senior standing.

Eligibility: Junior or Senior standing. Psychology major. Full-time status.

o Minimum overall GPA: 2.00

#### 4. Douglas Michell Memorial Scholarship: \$500

Purpose: Scholarship awards to students majoring in Psychology.

Eligibility: All class level+s. Psychology major. Must have completed at least 12 upper division units in Psychology with no grade lower than a C in upper division Psychology classes prior to the semester in which they are applying. Enrolled part-time or full-time.

o Minimum overall GPA: 2.00

o Preference: Interest in Humanistic Psychology.

# 5. George Parrott Scholarship: Up to \$1000

Purpose: For students with plans to continue on to a psychology graduate program, preferable out-of-state.

Eligibility: Awarded to a graduating senior psychology major. Financial need may be considered, but is not required. Student can be a full-time or half-time enrolled student.

Required materials:

o Minimum overall GPA: 3.50

- o Preference: Given to out-of-state graduate programs; and the applicant with the highest GPA.
- o Essay question: Briefly describe your educational goals as they pertain to pursuing graduate programs in psychology and whether those plans include out-of-state programs.
- o If applicable, GRE scores may be submitted and will be considered as part of the application

Deadline: November 30, 2023

#### 6. Arnold and Mari Golub Neuroscience Scholarship: \$960 or \$1,000

Purpose: Support students majoring in Psychology and who have a demonstrated interest in Neuroscience.

Eligibility: Senior standing. Psychology major.

Required materials:

- o Minimum overall GPA: 3.25 in Upper Division Psychology Courses
- Current transcript
- o Personal statement (250 words maximum; expressing your interest in Neuroscience and your goal of doing doctoral work)
- o A letter of recommendation from a Sacramento State faculty member

Deadline: November 30, 2023

## 7. John & Joyce Schaeuble Award for Best Use of Quantitative Data in Psychology: \$1000

Purpose: To provide an award for the best use of quantitative data in psychology by an undergraduate or graduate student in the Psychology Department.

Academic criteria:

- Undergraduate students
  - o Minimum GPA: 3.0 overall GPA
  - o Must have completed Psychology 121 with a grade of B or better. Preference given to students who have also completed or are currently taking Psychology 102.
- Graduate students
  - o Minimum GPA: 3.3 overall GPA
  - o Must have completed Psychology 202 with a grade of B or better. Preference given to students who have also completed or are currently taking Psychology 204 and/or Psychology 205.

## Research project and report criteria:

- Upload a report for a research project you previously did at Sacramento State that used quantitative methods of data analysis.
  - The report could be a research paper for a course in which you did the research, or a paper or poster you presented at a research conference, such as a regional or national conference of psychologists or a regional or national interdisciplinary conference in which a substantial portion of the program is psychological research.
  - O A conference presentation may be in any form that was acceptable for the conference, but it must provide enough information to explain how the research was conducted.
  - o Research that involves human subjects must have appropriate Institutional Review Board approval.
  - O Students who worked jointly and contributed equally on a project may apply together for an award to be shared, in which case each student must apply and meet the academic criteria for the award.
  - o Faculty may be listed as a co-author on a convention presentation, but students applying for the award must have done the report of the research and most of the work on the research.
- Answer the following questions about your research project on the application form:
  - o How did the way you conducted this research lead to the particular quantitative methods you used to analyze the data?
  - What other methods of analysis, if any, did you consider for the data? How might those other choices have contributed to an understanding of the data?
  - What assumptions were made about the data in the quantitative methods you used? How were those assumptions evaluated?
  - Describe any limitations with regard to the conclusions from your data analysis. For example, consider the statistical power of the study, the effect sizes of reported results, and confidence intervals for the reported statistics.
