Anchor Mission Statement

As developed by the Anchor University Advisory Council

As an Anchor University, Sacramento State aligns its resources and efforts to cultivate purposeful, long-term, mutually beneficial community partnerships that confront systemic inequities, transform the lives of our students, and strengthen our communities.

- Supports student success, antiracism, and inclusion work.

Examples of Anchor University Activities

From the 2019 Taskforce Report

1) Teaching & Learning

(e.g., service learning, academic internships, pedagogical design)

2) Co-Curricular Community Engagement

(e.g., via student or auxiliary organizations, Career Center, Carlsen Center, workforce development)

3) Research and Creative Activities

(e.g., training in community-based research/creative activities, expand internal and external funding sources, support existing programs)

4) Service

(e.g., expand community service opportunities, recognition, promotion, Day of Service, civic participation).

Anchor University Grants Programs

- Established in 2021 with donation from the University Foundation, later supplemented with University funds.
- 2022 grants are funded by University Enterprises, Inc. and supplemented with University funds.
- Two grant programs in 2022:
 - Anchor University Strategic Investment Grants
 - Anchor University Priority Grants - *new this year*

Example of Prior Grants

- **String Project Expansion**
- The Music Department was awarded a grant to provide free/low-cost classes in violin, cello, and orchestra to approximately 75 underserved Sacramento children. Lessons were taught by music majors enrolled in MUSC 60/160.
- This project expands a program with the Robla School District in which Sac State offers free or low-cost classes in violin, cello, and orchestra to children in some of the city's poorest neighborhoods.
- Participants come to campus for group and private lessons from Music majors, progressing from beginners to musicians who perform for their families in the Music Recital Hall in Capistrano Hall.

Anchor University Strategic Investment Grants

- Deadline: Monday, April 4, 2022, at 5:00 p.m.
- Award Cycle: July 1, 2022 – June 30, 2023
- One Application Allowed Per Applicant
- Applications must be submitted online via InfoReady Review at <https://csus.infoready4.com>
- Report required at the conclusion of grant period
- There is a total of \$25,000 available for grants. The award maximum is \$5,000.

Anchor University Strategic Investment Grants

- Projects must address at least one of the following priority issues health and well-being, inclusive economic opportunity and workforce development, pre-kindergarten through 12th-grade education, environmental sustainability and mobility, homelessness and housing, and/ or arts and culture.
- Projects must also advance both student success and the University's anti-racism & inclusion efforts.
- Applicants are required to engage with least one community partner, partnership letter required
- Any faculty member (tenured, tenure track, part-time), staff member, students, and student organization are eligible to apply.

Anchor University Strategic Investment Grants

Permissible Expenses (all must follow existing University policies and procedures):

- Supplies and materials
- Equipment
- Mileage reimbursement
- Food, drinks, and refreshments
- Student employment
 - The Student Assistant job classification shall be used for all payments to students.
- Payment to a non-profit organization or K-12 school
- Payment to non-CSU employed individual to perform services
- Honorarium to non-CSU employed individual
- Payment to a business to perform services
- Payment to a guest speaker
- Payment to an individual providing training services

Anchor University Strategic Investment Grants

Non-permissible expenses:

- Gift cards
- Tuition assistance or scholarships for enrolled students
- Staff stipend or bonus
- Faculty assigned time/ release time
- Student stipend and paid student internships*
 - Paid student internships can be allowed when using the Student Assistant job classification. Students in such positions can still be called an “intern” as a working title. If approved by the academic college, academic credit can be offered in accordance with existing University policies and procedures (i.e. with a 195/ 295 course).
- MPP bonus or stipend

Anchor University Priority Investment Grants

- New this year, aims to grow or sustain existing anchor efforts
- Deadline: Monday, April 4, 2022, at 5:00 p.m.
- Award Cycle: July 1, 2022 – June 30, 2023
- One Application Allowed Per Applicant
- Applications must be submitted online via InfoReady Review at <https://csus.infoready4.com>
- Report required at the conclusion of grant period
- There is a total of \$45,000 available for grants. The award maximum is \$15,000.

Anchor University Priority Grants

- Goal is to fund a small number of larger projects that will result in sustainable community partnerships.
- Priority Grants are to be used to facilitate the growth and/ or the operational stability of an existing Sacramento State community partnership that is already working to address one or more of the priority issues (existing for at least 12 months prior).
- Ideal projects will be interdisciplinary and have opportunities and roles for faculty, staff and students.
- Funds can also be used to leverage, or plan for, additional funding opportunities that may become available.

Anchor University Priority Grants

- Projects must address at least one of the following priority issues: health and well-being, inclusive economic opportunity and workforce development, pre-kindergarten through 12th-grade education, environmental sustainability and mobility, homelessness and housing, and/ or arts and culture.
- Projects must also advance both student success and the University's anti-racism & inclusion efforts.
- Applicants are required to engage with least one community partner, partnership letter required
- Any faculty member (tenured, tenure track, part-time), staff member, students, and student organization are eligible to apply.

Anchor University Priority Grants

Preferred applicants will:

- Expand opportunities for collaborative scholarship.
- enhance Sacramento State students' civic engagement skills.
- Augment a community partner's research, evaluation, and/or service capacity.
- leverage additional funding to ensure the stability of the project or partnership.
- Activities will have faculty, staff, and students' roles.
- Activities will be interdisciplinary.

Anchor University Priority Grants

Permissible Expenses (all must follow existing University policies and procedures):

- Supplies and materials
- Equipment
- Mileage reimbursement
- Food, drinks, and refreshments
- Student employment*
 - The Student Assistant job classification shall be used for all payments to students.
- Payment to a non-profit organization or K-12 school
- Payment to non-CSU employed individual to perform services
- Honorarium to non-CSU employed individual
- Payment to a business to perform services
- Payment to a guest speaker
- Payment to an individual providing training services

Anchor University Priority Grants

Permissible Expenses (continued):

- **With prior approval from manager or Faculty Advancement:**
 - Faculty assigned/ release time or “additional employment” (ex. 3 unit buy out or summer pay) related to the Anchor project
 - Staff stipend for temporary project coordination or lead work functions related to the Anchor project

Anchor University Priority Grants

Non-permissible expenses:

- Gift cards
- Tuition assistance or scholarships for enrolled students
- Student stipend and paid student internships
 - Paid student internships can be allowed when using the Student Assistant job classification. Students in such positions can still be called an “intern” as a working title. If approved by the academic college, academic credit can be offered in accordance with existing University policies and procedures (i.e. with a 195/ 295 course).
- MPP bonus or stipend
