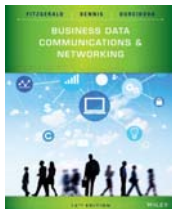

COURSE PREREQUISITE:

2. MIS 015 or CSC 015.

CATALOG COURSE DESCRIPTION:

MIS 140. Business Telecommunications. Examinations of issues involved in establishing telecommunications systems in a business organization. Introduction to basic terminology and hardware/software components of networks, including components of voice systems, local area networks, and client-server technology. Emphasis is on feasibility analysis of different telecommunications alternatives in typical business settings. Student will prepare reports on actual business telecommunications configurations.

No photographing, recording, or text messaging is allowed without written permission of the instructor.

COURSE METHODOLOGY:

Lectures will be presented to supplement the subject matter covered in the text. Students will be expected to have completed the reading assignments prior to class and to participate in class discussions which will center around the important material covered in each chapter. You will also be expected to be prepared for unannounced quizzes. Homework assignments will consist of sets of objective questions covering the reading assignments. The students will be expected to turn in homework on time. *Any late homework will **not** be accepted.*

Students will be expected to take the exams when scheduled. Students missing an exam will receive a zero for that exam

unless a valid reason for missing the exam can be verified. There are no "make-up" exams. If an exam is missed **with a valid reason**, the weight for that exam will be added to the weight for the final exam.

Final course grades will follow the standard straight scale of:

- 91%+ for an A,
- 90%+ for an A-
- 89%+ for a B+
- 81%+ for a B,
- 80%+ for a B-
- 79%+ for a C+
- 71%+ for a C,
- 70%+ for a C-, and
- 60%+ for a D.

Non-passing grades will be either D or F (no '+' or '-').

There should be no expectation of a 'curve' in the final course grading.

It is the student's responsibility to validate any grade that they receive. Sometimes an assignment may have a mistake in its grading. Students must review their graded assignments in a timely manner. Students must raise any questions regarding the grading of their assignments prior to the end of finals week. After finals week, the recorded points for any grading component will not be changed.

Special grades:

** 'WU' stands for 'Unauthorized Withdrawal'. This will only be considered for students who have not participated in the course after the fourth week of the course.

** 'I' stands for 'Incomplete'. This will only be considered when the policies and procedures of the College are followed (see http://www.csus.edu/cba/ubac/Documents/Std11rev_003.pdf). Any incomplete petition must be approved prior to the end of the 15th week of the semester.

*NOTE: This is a course for business students. Therefore, it is expected that all work for this course will be presented in a very neat and professional manner. Style, spelling, grammar, and presentation are components of all grading. **No handwritten homework or assignments will be accepted!***

EXAMINATIONS:

Examinations in this course are challenging. Each examination is self contained - you only need to bring a pencil/pen. The examinations are primarily problem based and calculators will be provided to ensure an even playing field. All examinations are Closed book – Closed everything!! (no notes; no calculators; no PDAs, no Cell Phones, no ear buds, etc; no talking; no neighbors; no hats – I want to see your eyes)!

A set of prior examination questions is accessible through SacCT (in Adobe Acrobat -.pdf format). These documents contain questions that have been used on Professor Sandman's MIS 140 examinations for the past several years. Many of the

questions seem to repeat themselves, but they are often slightly different. These documents are available to enhance the ability of MIS 140 students to gauge their progress with the material.

HOMEWORK:

Homework sets will be accessible through SacCT. Homework assignments are due at the time indicated on SacCT. These are individual assignments and no collaboration is allowed. Students may submit homework sets 1 through 12 as many times as they wish prior to the due date, and only the highest score attained for each of the homework sets will count toward the course grade.

The quizzes related to these homework assignments **MUST** be submitted via SacCT by **MIDNIGHT** on the date specified. Any homework not submitted by the deadline will not be accepted or graded.

1. **READ** the appropriate chapter in your Fitzgerald and Dennis textbook:
2. **RETURN** to the Homework page on the MIS 140 SacCT website. Then follow the appropriate link to answer 15 questions related to the chapter you have just read. These 15 questions are randomly chosen from pools of 50 to 100 questions, depending on which chapter you are reviewing. You have 30 minutes to take the quiz.
3. **REPEAT** taking *each homework quiz* as often as you wish until the deadline. You must wait 10 minutes between attempts (so you can read the text and learn what you missed!). *Note : each time you take a quiz for a specific chapter you will most likely have a completely different set of questions!*
4. Only your **HIGHEST SCORE** will be the score recorded for this homework assignment.
