CALPERS Update

The vast majority of Californians have no idea what CALPERS has done for all of us over many years. Certainly, our benefits are special. They have contributed significantly to the ability of the State to employ and hold generally competent and honest staff, not to mention fine faculty to support institutions which have been characterized as the fuel that drives our economic machine.

Few people, even beneficiaries, realize or remember that PERS has helped to bail out the State on a number of occasions. Even fewer know that there have been many years when there was little or no need for participating entities to make their contributions. If this fact were addressed in statements about the currently projected rising cost, folks would not be nearly as likely to accept the assertion that change is needed. Following my retirement, I participated in defined contribution programs in Minnesota and Colorado. These states contributed nearly ten percent to my accounts during years when my income was substantial. The return is substantially short of what PERS has accomplished.

Moreover, once those States make their fixed contribution, defined by law and collective bargaining contracts, they have no opportunity to benefit during times when there is a surplus. They just keep paying the fixed amount, year after year. We may not be directly impacted by the changes proposed by the Governor and I am not sure how to stop him. We do care, however and we ought to take every opportunity to educate others about the issues and then encourage them to spread the word. Given the cost of the proposed election and the tangible service that PERS has provided to the State and other participating organizations, it is difficult to find a rationale for what is underway. It is not too difficult to hypothesize about who the real winners would be if this proposal is implemented-surely not the people of the state of California!




While you are reading this, I will be in the midst of my twelfth visit to South Africa. Being there is always a
