Why This Program Exists?

Protecting Youth in our Programs

- Ensure the safety of children participating in Sac State-sponsored events/programs
- Protect employees and the university

Claim Settlements

- Penn State: \$237mm
- Baylor: \$223mm
- UCLA: \$215mm
- USC: \$1bn

* The average sexual molestation/abuse claim cost is now \$7mm

* Reputational cost can be even more damaging.

Sexual Abuse Statistics:

1 in 10 public school children, accounting for 4.5 million students, have experienced sexual misconduct by an educator.

“Youth Program”?

- All events, operations, or activities, in-person or virtual, designed for participation by minors **organized by Sac State** in which youth program personnel are responsible for the care, custody, or control of minors; and
- All events, operations, or activities for participation by minors administered by an **auxiliary organization or other third-party organization** on or of Sac State property.

2. Background Checks

Any University employee (faculty/staff), student employee, auxiliary organization, independent contractor, or volunteer who will serve as a designated individual in any University-sponsored program, must clear a background check.

Youth Protection Program Requirements

4. Abuse Reporting Procedures

If a program participant discloses any type of abuse or there is reason to suspect, the suspected incident shall be reported immediately.
