1. Open your browser and go to <u>https://my.csus.edu/</u>. Open your **Student Center**



2. Once you are logged into your Student Center, click on Switch to Full Site



3. In your full site **Student Center**, navigate to the **Academics** section and in the dropdown select **Veterans Benefit**



Note: If you using the **Cal Vet Fee Waiver**, do not submit an enrollment certification request. You will need to submit your approved CalVet Fee waiver authorization letter each academic year by **emailing a .pdf attachment** to <u>vets@csus.edu</u>
