



Housing Application for Summer 2021

Available: April 1, 2021 at 1 p.m.

- Summer housing accommodations will be available in American River Courtyard (AMC).
- Summer housing accommodations will be available on a first come-first serve basis.
- Summer housing assignments will be made by Housing staff. Students confirmed for housing will be provided their assignment information beginning on April 27, 2021.
- A \$175 application installment fee must be paid to complete your summer housing application. These funds will be applied toward total rent due.
- Payment of Summer housing rent charges is required by the 1st Friday of classes of the session. See payment schedule for details and due dates.
- Please note that meal service is not included in the summer license agreement and is not required for the summer.

Submit On-Campus Housing Application!

- Access the application through [HornetHousing](#) beginning on April 1, 2021.
- Read all materials and attachments very carefully.
- After following the instructions and providing all necessary information, you will electronically sign and submit your application.

- If under the age of 18 when you submit the application, your parent/guardian must also electronically sign the License Agreement Terms and Conditions. Your parent/guardian will receive an email link to sign the agreement.
 - You will receive a notification through your Sac State email once you click on the "Submit Application" button.
 - Your application will then be processed.
 - In 1-3 business days, you will receive an acknowledgment email that you may continue with the application process and make your \$175 application installment payment.
 - All communication will be sent through your Sac State email. Check for messages on a regular basis.
 - When payment is verified, you will receive an email that states your application is completed.

Cancellation

- Students wishing to cancel their summer application for any reason may do so before the designated deadline. Cancellation requests submitted after these dates are subject to approval.
- Applicants need to cancel through the housing application site.
- A \$175 cancellation fee will apply.
- Summer Session 1 and All Summer deadline: May 21, 2021
- Summer Session 2 deadline: July 2, 2021
- Housing cancellation requests should be submitted through [HornetHousing](#).
