

# **Summer Session 2025**

Summer classes are offered through the College of Continuing Education (CCE). Eligibility, class schedules, registration, and fees are determined by CCE. Visit the CCE's website for full details (<u>www.cce.csus.edu/summer</u>).

## Who's Eligible

**Continuing students:** Those enrolled in Spring 2025 or Fall 2024, but will not graduate prior to Summer 2025. **Enrollment begins April 7.** 

**Community members:** Individuals not formally admitted to the university, students who have been admitted to another college, and students who have been admitted to Sacramento State for Fall 2025. **Enrollment begins May 7.** 

## **Sessions Offered**

- First 6-week session (6W1) from May 27 July 6
- Second 6-week session (6W2) from July 7 August 17
- Full 12-week session (12W) from May 27 August 17

## **Summer Registration Fees**

Course Fees: Undergraduate: \$320 per unit | Post Baccalaureate: \$371 per unit

### **Campus Mandatory Fees:**

*Note:* Fees will be billed to your account in TWO parts. The course fee charges will appear on your account the day after you register. The remaining mandatory term fees will calculate later, and may take up to a week to appear on your account. Check your Student Center for the Campus Mandatory fees due date.

The CSU system makes every effort to keep student costs to a minimum. Fees listed in posted schedules or student accounts may need to be increased when public funding is inadequate. Therefore, CSU must reserve the right, even after initial fee payments are made, to increase or modify any listed fees, without notice, until the date when instruction for a particular semester has begun. All CSU-listed fees should be regarded as estimates that are subject to change upon approval by The Board of Trustees.

### Examples of how the course & campus mandatory fees are calculated:

**EX:** Undergraduate enrolls in 6 units  $\rightarrow$  (6 units x \$320 per unit) + \$554 CMF = <u>\$2,474</u> **EX:** Graduate student enrolls in 3 units  $\rightarrow$  (3 units x \$371 per unit) + \$554 CMF = <u>\$1,667</u>

## **Financial Aid**

Available only for eligible continuing Sacramento State students. *New students starting in Fall 2025 are not eligible.* 

### Eligible students must meet the all the standard criteria below to qualify:

- ✓ Must have a 2024-25 FAFSA filed by June 30, 2025.
- ✓ Must meet Satisfactory Academic Progress by the end of Spring 2025.
- ✓ Must have Pell Grant and/ or Federal Loan eligibility.

## **Types of Aid**

**Summer Pell Grant** is offered to undergraduates only and eligibility is based on remaining life-time limits. Aid consideration begins upon enrollment into **one class** and should reflect on your *Student Center > View Financial Aid > 2025 award link if awarded*. Amounts will vary based on your own individual file and eligibility. **Use the Summer Pell Grant Eligibility form (Page 4) to help estimated your award amount.** 

**Summer Loan** is offered to undergraduates **and** post-baccalaureates based on Federal Subsidized/ Unsubsidized loan eligibility. Students who are interested must submit the **Summer Loan Request e-form** located on their *Student Center> Financial Aid Links section*.

 If you were enrolled in Fall 2024/Spring 2025 and have unused Subsidized or Unsubsidized loans that was not used from the current fall/spring semester, you may request for the funds by April 25 using the <u>Change in Aid eform</u>.
