

**Sacramento State Title IX Sexual Misconduct  
Annual Report for July 1, 2018 – June 30, 2019**

The following report is in accordance with Executive Order 1095. Sacramento State's reports this information annually on October 1, for the prior fiscal year (July 1 to June 30). The information is reported in a manner that protects the privacy of the persons involved, including victims, respondents, witnesses, and shall be posted on the Campus website. William Bishop, Sacramento State Director of Equal Opportunity & Title IX Coordinator, is responsible for preparing and publishing the annual report.

This report differs from the University's Annual Security and Fire Safety Report (Clery Report) for various reasons. Complaints made to the Title IX Coordinator may have occurred away from Clery defined geography, therefore the statistics in this report, which take into account all reports regardless of geography, will be different than the statistics in the Clery Report. In addition, this report is based on fiscal year (July – June) whereas the Clery Report is based on calendar year (January – December).
